# Forsyth County Government COVID-19 Daily Briefing August 19, 2020

Updated weekdays by approximately 12:30pm

Nineteen new cases and two deaths have been reported since yesterday's daily briefing was issued. There have been 5,620 laboratory-confirmed cases in Forsyth County. All cases reported by the Forsyth County Department of Public Health are Forsyth County residents. Of the 5,620, 4,902 are presumed recovered. The case count is subject to change throughout the day but will only be reported once per day in the daily briefing.

The Public Health Director will provide a detailed briefing at 2:00pm at the beginning of the August 20th Board of County Commissioners meeting, which will be conducted remotely. The Public Health Director will hold a Question & Answer session with the media at 4:00pm on August 20th. The call-in information was sent to the media yesterday.






